Addenda No. 1 dated April 12, 2011 and Addenda No. 2 dated April 14, 2011 are hereby withdrawn. The Bid Specifications for Drainage Maintenance are hereby amended as follows:

Amendment No. 1: The 2nd Paragraph on Page 1 of 4 is hereby amended to read as follows:

Amendment No. 2: The 1st Paragraph of the INSURANCE AND LIABILITY Section on Page 4 of 4 regarding minimum coverage is hereby amended to read as follows:

INSURANCE AND LIABILITY

The successful Bidder shall present Certificates of Insurance, listing the City of Central as an additional insured, with the following minimum coverage:

Employers Liability	\$1,000,000
Comprehensive General Liability	\$2,500,000 <u>\$2,000,000</u> per occurrence and \$5,000,000 aggregate, which coverage shall include all defense and indemnity obligations assumed by Contractor in the Contract with the City of Central
Comprehensive Automobile and Vehicle Liability	\$2,000,000 per occurrence and \$5,000,000 aggregate coverage covering all owned leased or non-owned motor vehicles, including those used onsite and offsite
Professional Liability	\$2,500,000 per occurrence and \$5,000,000 aggregate
Workers' Compensation	Louisiana Statutory Requirement
<u>Umbrella Policy</u>	<u>\$5,000,000</u>

Amendment No. 3: The PERFORMANCE BOND Section on Page 3 of 4 is hereby amended to read as follows:

PERFORMANCE BOND

Upon execution of Contract, Contractor shall furnish a performance bond issued by a commercial surety authorized to do business in Louisiana in the total amount of the annual compensation for services for Year 1, Year 2 and Year 3. On or before July 1, 2013, Contractor shall furnish a performance bond in the total amount of the compensation for services for Years 4 and 5.
